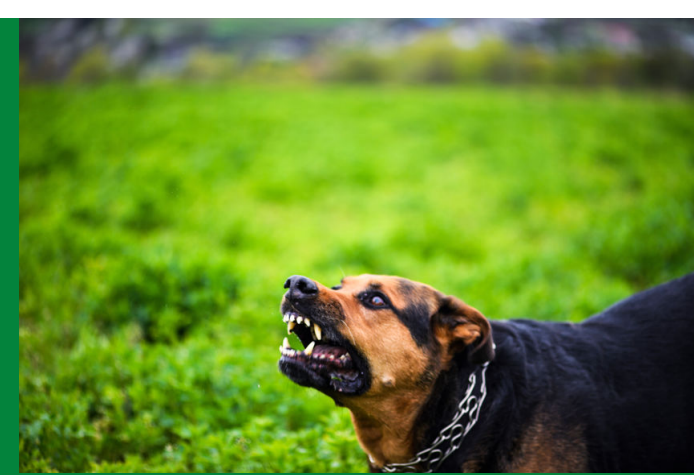

Avoiding the Nip: Legal Insights on Dog Bites



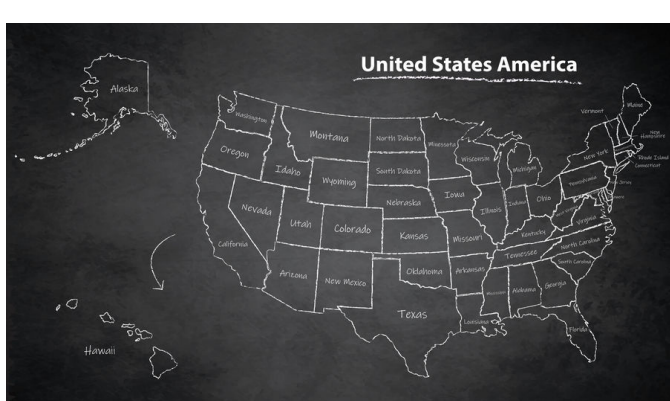

Speedy Shrimp Flatbreads

This delicious flatbread pizza is quick and easy. Perfect as an appetizer or meal.



INGREDIENTS

- 2 naan flatbreads or whole pita breads
- 1 package (5.2 oz) garlic-herb spreadable cheese
- 1/2 lb peeled and deveined cooked shrimp (31-40 per lb)
- 1/2 cup chopped oil-packed sun-dried tomatoes
- 1/4 cup fresh basil leaves
- Lemon wedges, optional

Directions

1. Preheat oven to 400°.
2. Place flatbreads on a baking sheet. Spread with cheese and top with shrimp and tomatoes.
3. Bake until heated through, 4-6 minutes.
4. Sprinkle with basil. If desired, serve with lemon wedges.
