# CAPRESE-STUFFED **CHICKEN**

## **Ingredients:**

- 4 boneless, skinless chicken breasts
- 2 cups baby spinach • 1 cup drained oil-packed sun-dried tomatoes, oil reserved
- 4 slices fresh mozzarella
- 11/2 Tbsp. Italian seasoning Kosher salt
- Freshly ground black pepper Kosher salt • Freshly ground black pepper
- **Directions:** • Preheat oven to 400°. On a work surface, cut a pocket into thickest side of chicken breast, being sure not to
